TO BE ELIGIBLE FOR NOMINATION TO THE HALL OF FAME, A CANDIDATE MUST MEET THE FOLLOWING REQUIREMENTS:

1. Must be forty (40) years of age or older.
2. Bowling Achievement:
 - a. If living, been a member of the Greater Harrisburg USBC or former association (HDBA, HWBA, Carlisle Bowling Association, HAYABA) for a minimum of twenty (20) years with an official 21 game average.
 - b. If deceased, been a member of the Greater Harrisburg USBC or former association (HDBA, HWBA, Carlisle Bowling Association, HAYABA) for a minimum of ten(10) years.

Meritorious Service

- a. If living, served as a Board Member or as a league officer of the Greater Harrisburg USBC or former association (HDBA, HWBA, Carlisle Bowling Association, HAYABA) for a minimum of twenty (20) years.
 - b. If deceased, served as a Board Member or as a league officer of the Greater Harrisburg USBC or former association (HDBA, HWBA, Carlisle Bowling Association, HAYABA) for a minimum of five (5) years.
3. Excelled in the sport of bowling and sportsmanship or distinguished service to the sport of bowling.
 4. Anyone currently under suspension by the United States Bowling Congress shall not be considered.
